RIGHTS & LIABILITIES OF A NOMINAL MEMBER

- 1) A person above the age of 18 years and living within the area of operation of the **A.A.I. Staff Co-operative Credit Society Ltd.**, may be admitted as Nominal Member on payment of Rs. 100/- as admission fee which is non-refundable. The Membership shall cease at the expiry of 3 years or after the clearance of his liability whichever is earlier.
- 2) A Nominal Member shall not be entitled to any share in any form in the assets or profits of the **A.A.I. Staff Co-operative Credit Society Ltd.**,
- 3) He/She shall not be eligible to attend General Body Meeting or to participate in the Management of the **A.A.I. Staff Co-operative Credit Society Ltd.**, and dividends & gifts as declared by society to its members.
- 4) He/She is not entitled to become an office bearer of the **A.A.I. Staff Co-operative Credit Society Ltd.**,
- 5) He/She shall have all the privileges, rights and facilities as per the Act, such as obtaining credit and to take recourse to arbitration in case of any dispute.
- 6) The liability of the Nominal Member of the **A.A.I. Staff Co-operative Credit Society Ltd.**, is limited to his/her share of deposit and other dues to the **A.A.I. Staff Co-operative Credit Society Ltd.**,
- 7) The Nominal Member is not eligible for overdraft facility ie. Loan against F.D.
The A.A.I. Staff Co-operative Credit Society Ltd.,
